2. **Program Procedure and Enrollment**. Participants may enter each Giveaway through an On-Site Entry via the Player PAYBACKTM App, as described below (an "Entry"). Participants may be required to present valid, government-issued photo identification for proof of age at the time of entry at a Participating Location. Each Giveaway shall be open to all patrons (regardless of whether such patron has or intends to play a Video Gaming Terminal or otherwise make a purchase) that is enrolled in the Player PAYBACKTM rewards program (the "Program") and has a valid phone number. Each person who enrolls in a Giveaway is referred to herein as a "Participant." Sponsors reserve the right to deny anyone from participating in a Giveaway at any time in Sponsors' sole discretion, and without recourse. In connection with initial enrollment in the Program, a Participant will be required to provide the following information: (a) first and last name, (b) telephone number, (c) gender and (d) date of birth (the "Required Participant Information"). In connection with a subsequent Entry, a Participant will be required to provide a telephone number. The Required Participant Information must be accurate and current as of the date of initial enrollment and as of each subsequent Entry. A Participant is permitted one (1) Entry per day per Participating Location and a Bonus Entry (as defined below) at one Participating Location per day, where applicable. Each Participant is limited to creating one account for the Program, which can be used for all Participating Locations.

ENTRY: Participants may enter the Giveaways by visiting the Participating Location and accessing the Player PAYBACKTM App that is available on the J&J designated tablet located near the gaming area at the Participating Location during normal business hours.

- a. **Find Your Fortune.** Participant will be automatically entered into the Find Your Fortune Giveaway upon completion of a valid check-in at the Participating Location. Limit one (1) automatic Entry per day per Participating Location. Participant will have a daily opportunity for an additional Find Your Fortune bonus entry ("Fortune Bonus") by inputting the code found at https://www.facebook.com/JJVenturesGaming. The Fortune Bonus can be applied for an additional entry at one (1) Participating Location of the Participant's choosing per day.
- b. **J&J Jackpot.** A Participant will be awarded up to three (3) Jackpot Points ("Giveaway Points") after playing the featured game during the applicable Entry Period on the tablet which awards Giveaway Points via ratio-based gamification. Participants must redeem three (3) Giveaway Points for an entry coupon each time they want to submit an Entry into a Giveaway. Limit (one) Entry per day per Participating Location.
- c. **Gameday Giveaway.** Participant will be automatically entered into the Gameday Giveaway upon completion of a valid check-in at the Participating Location. Limit one (1) automatic Entry per day per Participating Location. Participant will have a daily opportunity for an additional Gameday Giveaway bonus entry ("Gameday Bonus" and together with Fortune Bonus, the "Bonus Entry") by inputting the code found at https://www.facebook.com/JJVenturesGaming. The Gameday Bonus can be applied for an additional entry at one (1) Participating Location of the Participant's choosing per day.





It is the responsibility of the Participant to ensure that the Required Participant Information is accurate at the time of each Entry. All Participants must enter themselves in a Giveaway; a third-party (including an employee of any of Sponsors) may not enter another in a Giveaway. In the event that a Participant fails to comply with these Official Rules, at the sole determination of J&J, such Participant may be disqualified from a Giveaway. Moreover, if a Participant fails to comply with these rules, at the sole determination of J&J, all that Participant's Entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of the recipient's prizes. By entering in a Giveaway at the Participating Location, each Participant agrees that (A) they have read and accepted these Official Giveaway Rules; (B) they have read and accepted the Official Player PAYBACKTM Rules; (C) have read and accepted the Terms of Use which are available at https://www.jjventures.com/terms-of-use-2/ and incorporated by reference and made a part of these Official Rules; (D) have read and accepted J&J's Privacy Policy, which are available at https://www.jjventures.com/privacy-policy/ and incorporated by reference and made a part of these Official Rules. Participant acknowledges that submission of the Required Participant Information and any other information collected through the Program is subject to J&J's Privacy Policy.

3. **NO PURCHASE NECESSARY.** NO PURCHASE IS NECESSARY TO ENTER OR WIN THE GIVEAWAYS. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, ANY PRODUCT, GOOD OR SERVICE SOLD BY THE SPONSORS OR A PARTICIPATING LOCATION) WILL NOT IMPROVE A PARTICIPANT'S CHANCES OF WINNING WITH AN ENTRY.

4. Drawing.

- a. **Find Your Fortune**. The drawing will be conducted by a representative of J&J and will take place at J&J Gaming on May 16, 2022 (the "Find Your Fortune Drawing Date"). Entries will only be accepted from 12:00 AM (CST) April 1, 2022 through 11:59 PM (CST) May 15, 2022 (the "Find Your Fortune Entry Period"). An employee of J&J will conduct the drawing for each Participating Location and notify the Participating Location the winner information via email by May 19, 2022. The Participating Location shall contact the winner via telephone within 24 hours of the Find Your Fortune winner notification email (the "Find Your Fortune Notice") and the winner shall have three (3) days from the date and time of the Find Your Fortune Notice to claim his or her Prize (the "Find Your Fortune Claim Period, the Prize shall be forfeited, and a secondary drawing may occur at a date and time decided upon by the Sponsors (the "Find Your Fortune Secondary Drawing"). No additional Entries shall be accepted between the expiration of the Find Your Fortune Claim Period and the Find Your Fortune Secondary Drawing.
- b. **J&J Jackpot**. The drawing will be conducted by a representative of J&J and will take place at J&J Gaming on August 16, 2022 (the "J&J Jackpot Drawing Date"). Entries will only be accepted from 12:00 AM (CST) July 1, 2022, through 11:59 PM (CST) August 15, 2022 (the "J&J Jackpot Entry Period"). An employee of J&J will conduct the drawing for each Participating Location and notify the Participating Location the winner information via email by August 18, 2022. The Participating Location shall contact the winner via telephone within 24 hours of the J&J Jackpot winner notification email (the "J&J Jackpot Notice") and the winner shall have three (3) days from the date and time of the J&J Jackpot Notice to claim his or her Prize (the "J&J Jackpot Claim Period"). If the winner does not claim the Prize within the J&J Jackpot Claim Period, the Prize shall be forfeited, and a secondary drawing may occur at a date and time decided upon by the Sponsors (the "J&J Jackpot Secondary Drawing"). No additional Entries shall be accepted between the expiration of the J&J Jackpot Claim Period and the J&J Jackpot Secondary Drawing.
- c. **Gameday Giveaway.** The drawing will be conducted by a representative of J&J and will take place at J&J Gaming on the dates below (collectively, the "Gameday Giveaway Drawing Dates"). Entries will only be accepted from 12:00 AM (CST) November 1, 2022 through 11:59 PM (CST) December 15, 2022 (the "Gameday Giveaway Entry Period"). An employee of J&J will conduct the drawing for each location and notify the Participating Location with the winner information within 48 hours of the drawing date. The Participating Location shall contact the winner via telephone within 24



hours of the Gameday Giveaway Drawing Date (the "Gameday Giveaway Notice") and the winner shall have three (3) days from the date and time of the Gameday Giveaway Notice to claim his or her Prize (the "Gameday Giveaway Claim Period"). If the winner does not claim the Prize within the Gameday Giveaway Claim Period, the Prize shall be forfeited, and a secondary drawing may occur at a date and time decided upon by the Sponsors (the "Gameday Giveaway Secondary Drawing"). No additional Entries shall be accepted between the expiration of the Gameday Giveaway Claim Period and the Gameday Giveaway Secondary Drawing.

5. Prizes, Prize Values, Odds of Winning and Collecting Prizes.

- a. **Find Your Fortune.** One (1) Participant from each Participating Location will win the cash prize of \$300.
- b. **J&J Jackpot.** One (1) Participant from each Participating Location will win the cash prize of \$350.
- c. **Gameday Giveaway**. One (1) Participant from each Participating Location will win the cash prize of \$375.
 - i. Each week, five (5) Participants from across all locations as identified [https://www.jjventures.com/news/ (to be posted by October 17, 2022)] will win that week's cash prize. Cash Prize amount shown above in Section 4c. (Prize amounts awarded will depend on the number of Participating Locations).
 - ii. Any winner from Week 1 through Week 5 will be ineligible to win any of the remaining weeks' prizes. However, Participant will still be qualified to win the Grand Prize on 12/19/2022.
- d. The prize will be in the form of a check made payable to the winner and sent via certified mail to the address obtained when the winner is notified.
- e. The odds of winning either Giveaway depend entirely on the number of Entries made during the Find Your Fortune Entry Period, J&J Jackpot Entry Period, or the Gameday Giveaway Entry Period, as applicable.
- f. J&J Gaming will incur the cost of shipping or handling fees or charges associated with collecting the Prize.
- **6. Eligibility.** Each Giveaway is open to all legal residents of the United States of America who are twenty-one (21) years or older at the time of entry and are enrolled in the Program. Each Giveaway shall be open to all patrons who meet these criteria, regardless of whether such patron has or intends to play a Video Gaming Terminal. Employees of the Participating Location and the immediate family members of each employee are not eligible to check-in, earn Giveaway Points, or otherwise participate in the Giveaway at the location where that employee is employed. An "immediate family member" is defined to mean spouse, parent, grandparent, child or sibling. In-laws are not considered to be immediate family members. As applicable, employees of J&J, its affiliates, licensees, franchisees, advertising and promotional agencies are not eligible to participate in the Giveaways.





- 7. **Use of Disclosed Information.** Information transmitted to the Sponsors will generally be treated as nonconfidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each participant's name, biographical information and/or likeness for online posting and/or any other written or photographic advertising and publicity without additional compensation. Further, by enrolling in the Program or entering a Giveaway, Participant grants and authorizes Sponsors to contact Participant regarding the Program or a Giveaway, including periodic updates about the Program, J&J announcements and promotions, and announcements and promotions regarding any Participating Location where participant has checked-in, via text message, e-mail or regular mail. Participant may opt out of receiving such materials or messages by following the opt-out instructions set forth in the Player PAYBACKTM App or the applicable text message or e-mail. If Participant opts out, Participant authorizes Sponsors to send an email and/or text message confirming the request to opt out and Participant will no longer be enrolled in the Program or eligible to participate in a Giveaway. Participant acknowledges that additional charges from their mobile phone carrier may apply for text messages and Participant consents to same.
- 8. **Facebook Disclosure.** Although the Program or the Giveaways may be advertised on the Facebook pages of the Sponsors or another, neither the Program or the Giveaways are in any way sponsored, endorsed or administered by, or associated with, Facebook. Participants are providing their information to Sponsors and not to Facebook. The information a Participant provides will only be used by the Sponsors. By entering, Participants provide a complete release of Facebook from any and all responsibilities implied or provided by Sponsors and that this Program and each Giveaway is in no way sponsored, endorsed or administered by, or associated with, Facebook.

9. **Miscellaneous.**

- (a) By entering a Giveaway, Participants unconditionally agrees to be bound by these Official Rules and the decisions of J&J, which shall be final. Sponsor reserves the right to disqualify any Participant who, in its sole suspicion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner.
- (b) Participant acknowledges that Participating Location may elect to participate in one or both Giveaways.
- (c) All federal, state, and local laws apply. These Official Rules will be governed by the laws of the State of Illinois. If any provision of these Official Rules is deemed invalid or unenforceable, such provision shall be deemed void only for the specific jurisdiction at issue, but all other provisions will remain in full force and effect.
- (d) Sponsors and, as applicable, the employees, officers, directors, shareholders, agents, and representatives of the Sponsors, their affiliates, subsidiaries, and advertising, promotion and legal advisors are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible Entries; (ii) any condition caused by events beyond the control of either Sponsor that may cause the Giveaway to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of the Prize, or from participation in the Giveaway; or (iv) any printing or typographical errors in any materials associated with the Giveaway.
- (e) Participants agree that any dispute arising out of this Program or the Giveaway shall be resolved individually without class action and exclusively by the state and federal courts in Effingham County, Illinois under the laws of Illinois, without regard to that state's conflict of laws principles. PARTICIPANT, BY ENTERING, SPECIFICALLY AND KNOWINGLY WAIVES ANY RIGHT TO A TRIAL BY JURY AND A TRIAL BY JURY IS HEREBY WAIVED BY BOTH SPONSORS AND PARTICIPANT. PARTICIPANT UNDERSTANDS THAT PARTICIPANT IS WAIVING RIGHTS WITH RESPECT TO CLAIMS THAT ARE AT THIS TIME UNKNOWN OR UNSUSPECTED, AND IN ACCORDANCE WITH SUCH WAIVER, PARTICIPANT ACKNOWLEDGES THAT PARTICIPANT HAS READ AND UNDERSTANDS, AND HEREBY EXPRESSLY WAIVES, THE BENEFITS OF SECTION 1542 OF THE CIVIL CODE OF CALIFORNIA, AND ANY SIMILAR LAW OF ANY STATE, COUNTRY OR TERRITORY, WHICH PROVIDES AS FOLLOWS: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."
- (f) For the name of the winner or an additional copy of the Official Rules, send a self-addressed stamped envelope request to the principal place of business of the Participating Location identified in Section 1 above. The name of the winner will be available on or after three (3:00pm) the day after the Find Your Fortune Drawing Date, J&J Jackpot Drawing Date or Gameday Giveaway Drawing Date, as applicable.
