



OFFICIAL SWEEPSTAKES RULES

1. **Sponsorship.** The J&J Giveaway, (the “Sweepstakes”) is sponsored by *J&J Ventures Gaming, LLC* with a principal place of business located at 1500 S. Raney Street, Effingham, IL 62401 (the “Participating Location”).

2. **Sweepstakes Procedure.** Participants 21 and older may enter the Sweepstakes through Facebook all day on the date that the promotion is posted. Gaming fans have to “like”, “comment” with their answer, and “share” the J&J Gaming post within the promo period for a chance to win a prize. J&J will choose the winner at random. The Sweepstakes shall be open to all patrons (regardless of whether such patron has or intends to play a Video Gaming Terminal). Each person who enters the Sweepstakes via an Entry is referred to herein as a “Participant.” In connection with an Entry, a Patron may be required to provide the Participant’s: [(a) first and last name, (b) telephone number, (c) physical address and (d) e-mail address (the “Required Participant Information”)]. The Required Participant Information must be accurate and current as of the date of the Entry. A Participant is permitted one (1) Entry per day. All Participants must enter themselves in the Sweepstakes; a third-party (including the Sponsor’s employees) may not enter another in the Sweepstakes. In the event that a Participant fails to comply with any of the requirements contained in this Section or that are otherwise provided for herein, at the sole determination of the Sponsor, such Participant may be disqualified from the Sweepstakes. Moreover, at the sole determination of the Sponsor, all of that Participant’s Entries may be deemed null and void, not honored or acknowledged and may be grounds for forfeiture of his/her prizes.

3. **NO PURCHASE NECESSARY.** NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, ANY PRODUCT, GOOD OR SERVICE SOLD BY THE SPONSOR) WILL NOT IMPROVE A PARTICIPANT’S CHANCES OF WINNING WITH AN ENTRY.

4. **Drawing.** The drawing will be held at the Participating Location on the next business day after the promotion period specified in the social media post (the “Drawing Date”). Entries will only be accepted until the end of the day on the last day of the promotion period stated in the post. The winner shall be notified via Facebook Message within 24 hours of the Drawing Date (the “Notice”), and shall have 3 days from the date and time of the Notice to claim his or her Prize (the “Claim Period”). If the winner does not claim the Prize within the Claim Period, the Prize shall be forfeited.

5. **Prizes, Prize Values, Odds of Winning and Collecting Prizes.**

- (a) By entering the Sweepstakes, Participants are eligible to win one (1) J&J promotional item or the stated number of J&J Gaming points on their J&J Gaming app account, as specified in the promotional post. The number of winners will be specified within the rules of the post.
- (b) The odds of winning depend entirely on the number of Entries made prior to the Drawing Date.
- (c) There are no shipping or handling fees or charges associated with collecting the Prize.
- (d) Winning entries from any JJVG Facebook Promotion will then be voided for subsequent raffles that are within a 3-month time period.

6. **Eligibility.** The Sweepstakes is open to all legal residents of the United States of America who are twenty-one (21) years or older at the time of entry. The Sweepstakes shall be open to all patrons who meet these criteria, regardless of whether such patron has or intends to play a Video Gaming Terminal. Employees of Sponsor, third party administrator (“Administrator”), and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Sweepstakes Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same

household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply.

7. **Use of Disclosed Information.** Information transmitted to the Sponsors will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, entry constitutes permission to use each winner's name, biographical information and/or likeness for online posting and/or any other written or photographic advertising and publicity without additional compensation. Further, by entering the Sweepstakes, the Participant is granting Sponsor permission to use his/her contact information to provide him/her with marketing or other informational materials related to Sponsor.

8. **Facebook Disclosure.** Although this Sweepstakes may be advertised on the Facebook pages of the Sponsors or another, this Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook. Participants are providing their information to Sponsors and not to Facebook. The information a Participant provides will only be used by the Sponsors. By entering, Participants provide a complete release of Facebook from any and all responsibilities implied or provided by Sponsors and that this Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Facebook.

9. **Miscellaneous.**

- (a) By entering, Participants unconditionally agree to be bound by these rules and the decisions of the Sponsor, which shall be final. Sponsor reserves the right to disqualify any Participant or winner who, in its sole suspicion, tampers with the entry process, violates these rules, or acts in an unsportsmanlike or disruptive manner.
- (b) All federal, state, and local laws apply.
- (c) Sponsors and, as applicable, the employees, officers, directors, shareholders, agents, and representatives of the Sponsors, their affiliates, subsidiaries, and advertising, promotion and legal advisors are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible Entries; (ii) any condition caused by events beyond the control of either Sponsor that may cause the sweepstakes to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by a prize or resulting from acceptance, possession, or use of the Prize, or from participation in the Sweepstakes; or (iv) any printing or typographical errors in any materials associated with the sweepstakes.
- (d) Participants agree that any dispute arising out of this Sweepstakes shall be resolved individually without class action and exclusively by the state and federal courts in Effingham County, Illinois under the laws of Illinois, without regard to that state's conflict of laws principles.
- (e) For the name of the winner or an additional copy of the Official Rules, send a self-addressed stamped envelope request to the principal place of business of the Participating Location. The name of the winner will be available the day after the Drawing Date.
