



## OFFICIAL SWEEPSTAKES RULES (“Official Rules”)

**NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE A PARTICIPANT’S CHANCES OF WINNING.**

**1. Sponsorship.** *Red, White & Win Sweepstakes*, this “Sweepstakes”, is sponsored by J&J Ventures Gaming, LLC (“J&J” or the “Sponsor”), with its principal place of business located at 1500 S. Raney Street, Effingham, Illinois (the “Main Office”).

**2. Program Procedure and Enrollment.** Participants may enter this Sweepstakes by visiting a location, establishment, or place of business that has entered into a Terminal Placement Agreement with J&J (a “J&J Location”) and accessing the Player PAYBACK® Rewards Program found on the J&J Gaming Application (the “J&J App”) by downloading the J&J App on his or her mobile device (an “Entry”). If not previously enrolled, Participants will be required to enroll in the Sponsor’s Player PAYBACK® Program (the “Program”) and adhere to the Official Rules for the Program (“Program Official Rules”). Participants may be required to present valid, government-issued photo identification for proof of age. Each person who enrolls in this Sweepstakes is referred to herein as a “Participant.” Sponsor reserves the right to deny anyone from participating in this Sweepstakes at any time in Sponsor’s sole discretion and without recourse. In connection with initial enrollment in the Program, a Participant will be required to provide the following information: **(a) first and last name, (b) telephone number, (c) date of birth, and (e) email address (the “Required Participant Information”).** Participant may be required to validate his or her phone number through a verification code sent via text message to the Participant for each subsequent Entry into the Sweepstakes. The Required Participant Information must be accurate and current as of the date of initial enrollment and as of each subsequent Entry. A Participant is permitted one Entry (as defined below) per day at each location with the possibility to earn Bonus Entries as set forth below. Each Participant is limited to creating one (1) account for the Program which shall be used for all of the Participant’s Entries.

**3. ENTRY PERIOD:** Entries will only be accepted from 12:00 AM (CST) on July 1, 2026 through 11:59 PM (CST) on August 12, 2026 (the “Entry Period”). For the full entry period schedule, see the details set forth in Section 8.

**4. ENTRY:** Participants are automatically entered into the Sweepstakes upon completion of a valid Check-In at any J&J Location during the Location’s normal business hours (“Check-In”). A valid Check-In can be completed while on-site at a J&J Location by signing into the J&J App and completing the check-in process. A Participant may Check-In multiple times a day at multiple Participating Locations; however, a Participant is limited to one (1) Entry a day per J&J Location into the Sweepstakes despite the number of Check-Ins a Participant has completed at a J&J Location in one day. Therefore, a Participant may Enter multiple times per day, with one valid Check-In permitted per J&J Location.

**a. Monday Double Entry Days:** On Mondays throughout the Sweepstakes, Participants will earn additional double Entries (each a “Double Entry Day”). On a Double Entry Day, upon completion of a successful Entry, a Participant will be awarded a doubled amount of Entries otherwise qualified for during the Entry Period (each a “Double Entry”). For the avoidance of doubt, Double Entries include any Bonus Entries qualified for by each Participant (as described below). For example, if a participant in the VIP Level earns one (1) Entry plus three (3) Bonus Entries, on Double Entry Days, the participant will have earned a total of eight (8) Entries into the sweepstakes for that Check-in.

**5. BONUS ENTRY:** Each time a Participant completes an Entry into the Sweepstakes, the Participant may qualify for additional and automatic Entries into the Sweepstakes (“Bonus Entry/Entries”). A Participant’s qualification for or allocation of Bonus Entries is determined by the Participant’s Loyalty Tier in the Program (as defined by and more fully set forth in the Program Official Rules) as of July 1, 2026. Therefore, a Participant’s qualification and allocation of Bonus Entries is as follows:

- a. Non-reward level status (a “Member”) does not qualify for Bonus Entries;
- b. Insider Level qualifies for one (1) Bonus Entry;
- c. Elite Level qualifies for two (2) Bonus Entries; and
- d. VIP Level qualifies for three (3) Bonus Entries.



**6. Responsibilities of Participant.** It is the responsibility of the Participant to ensure that the Required Participant Information is accurate at the time of each Entry. No third party or an employee of the Licensed Establishment may enter this Sweepstakes on behalf of a Participant. In the event that a Participant fails to comply with these Official Rules, at the sole determination of J&J, such Participant may be disqualified from this Sweepstakes. Moreover, if a Participant fails to comply with these Official Rules, at the sole determination of J&J, all of Participant's Entries may be deemed null and void, not honored or acknowledged, and may be grounds for forfeiture of Participant's prize(s). By entering this Sweepstakes, each Participant agrees that (A) they have read and accepted these Official Rules; (B) they have read and accepted the Sponsor's Official Player PAYBACK® Rules which are available at <https://www.jjgaming.com/wp-content/uploads/2024/09/Rules-Regulations.pdf>; (C) have read and accepted the Terms of Use which are available at <https://www.jjgaming.com/terms-of-use/> and incorporated by reference and made a part of these Official Rules; and (D) have read and accepted J&J's Privacy Policy, which is available at <https://www.jjgaming.com/privacy-policy/> and incorporated by reference and made a part of these Official Rules. Participant acknowledges that submission of the Required Participant Information and any other information collected through the Program is subject to J&J's Privacy Policy. Sponsor is not responsible for lost, late, corrupted, or misdirected entries, whether due to technical or computer malfunctions or otherwise.

**7. NO PURCHASE NECESSARY.** NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. FURTHER, A PURCHASE (INCLUDING, WITHOUT LIMITATION, ANY PRODUCT, GOOD OR SERVICE SOLD BY THE SPONSORS OR A PARTICIPATING LOCATION) WILL NOT IMPROVE A PARTICIPANT'S CHANCES OF WINNING WITH AN ENTRY.

**8. Drawing.** Winners of the Sweepstakes will be drawn according to the tables below. The drawing will be conducted by a representative of J&J and will take place at J&J's Main Office on dates below. Winners will be notified by a push notification via J&J Gaming app within 48 hours of the Drawing Date (the "Notification Date"). Prior to mailing each Prize (as defined below), the winner must provide Sponsor with (a) a completed "Affidavit of Eligibility Release and Prize Acceptance Form" and, if applicable, (b) the information required to complete Form 1099-MISC, and (c) a completed W-9 (collectively the "Winning Requirements"). The failure to provide the Winning Requirements within three (3) days of the Notification Date shall result in the winner forfeiting the prize, and a secondary drawing may occur at a date and time decided upon by the Sponsor.

**9. Prizes, Prize Values, Odds of Winning and Collecting Prizes.**

- a. **Prizes.** On the Weekly Drawing Dates, all Entries, Double Entries, and Bonus Entries (collectively “Qualified Entries”) submitted during the relevant Entry Period will be combined and ten (10) Participants from each Loyalty Tier will win the cash prize of two hundred and fifty dollars (\$250.00). Additionally, from the combined Qualified Entries, one (1) Participant from each Loyalty Tier will win the cash prize of two thousand five hundred dollars (\$2,500).
- b. J&J will mail each prize to the winner in the form of a check made payable to the winner and sent via certified mail to the address obtained when the winner is notified by phone.
- c. A Participant is not eligible to win more than one Prize per Entry Period; however, a winner is eligible to win a Grand Prize.
- d. The odds of winning depend entirely on the number of Entries made during the Entry Period, as applicable.

**10. Eligibility.** This Sweepstakes is open to all natural persons who are (a) residents of the fifty (50) United States (excluding residents of New York, Florida and Rhode Island); (b) are enrolled in the Program; (c) have a valid phone number; and (d) at the time of entry, are at least twenty-one (21) years of age. Participants do not have to play or intend to play a Video Gaming Terminal to enter or win. Owners and their immediate family members of a licensed establishment that has entered into a Terminal Placement Agreement with J&J are ineligible to participate in the Sweepstakes. Employees and immediate family members of employees of a J&J Location are not eligible to enter at the J&J Location where the employee is employed but may enter at any other J&J Location. An “immediate family member” is defined to mean spouse, parent, or child. In-laws are not considered to be immediate family members. Further, as applicable, employees of J&J and their immediate family members, J&J affiliates, licensees, franchisees, and advertising and promotional agencies servicing J&J are also not eligible to participate in this Sweepstakes.

**11. Use of Disclosed Information.** Information transmitted to the Sponsor will generally be treated as non-confidential and non-proprietary. Except where prohibited by law, an Entry constitutes permission to use each Participant’s name, biographical information and/or likeness for online posting and/or any other written or photographic advertising and publicity without additional compensation. Further, by enrolling in the Program or entering this Sweepstakes, Participant grants and authorizes Sponsor to contact Participant regarding the Program or this Sweepstakes, including periodic updates about the Program, J&J announcements and promotions, and announcements and promotions regarding any J&J Location where Participant has Checked-In via push notification, e-mail or regular mail. Participant may opt-out of receiving such materials or messages by following the opt-out instructions set forth in the J&J App or the applicable e-mail. Participant may also elect to delete his or her Player PAYBACK® account by visiting the Personal Details section of the J&J App and completing the “Delete Account” module. If Participant deletes his or her account, Participant will no longer be enrolled in the Program or eligible to participate in this Sweepstakes.

**12. Social Media Disclosure.** Although the Program or this Sweepstakes may be advertised on the Facebook pages, X (formerly known as Twitter) accounts, Instagram accounts, YouTube channel or other social media platforms of the Sponsor, neither the Program nor this Sweepstakes is in any way sponsored, endorsed or administered by, or associated with, Facebook, X, Instagram, YouTube or other social media platforms. Participants are providing their information to the Sponsor and not to Facebook, X, Instagram, YouTube or other social media platforms. The information Participant provides will only be used by Sponsor and its agents. By entering, Participants provide a complete release of Facebook, X, Instagram or YouTube from any and all responsibilities implied or provided by the Sponsor and that the Program and this Sweepstakes are in no way sponsored, endorsed or administered by, or associated with, Facebook, X, Instagram or YouTube.



### 13. Miscellaneous.

- (a) By entering this Sweepstakes, Participant unconditionally agrees to be bound by these Official Rules and the decisions of J&J, which shall be final. J&J reserves the right to disqualify any Participant who, in its sole opinion, tampers with the entry process, violates these Official Rules, or acts in an unsportsmanlike or disruptive manner.
- (b) All federal, state, and local laws apply. These Official Rules will be governed by the laws of the State of Illinois. If any provision of these Official Rules is deemed invalid or unenforceable, such provision shall be deemed void only for the specific jurisdiction at issue, but all other provisions will remain in full force and effect.
- (c) For each of the Prizes, the Internal Revenue Service (IRS) requires Form 1099-MISC for U.S. residents for each winner who receives a Prize if the amount of the Prize is \$2,000 or more. The winner of a prize valued at \$2,000 or more must provide J&J with the required information in order for J&J to complete Form 1099-MISC. Additionally, J&J will send the winner a W9, which must be completed and returned to J&J for the winner to receive the Prize. Any winner who fails to promptly (i.e., within three (3) business days) provide information sufficient to complete Form 1099-MISC and does not send J&J a W9, including, without limitation, his or her social security number, shall forfeit any and all rights to the Prize. Each winner is solely responsible for reporting and paying all applicable federal, state and local taxes related to the prize. Prizes are non-transferable.
- (d) Sponsor and, as applicable, the employees, officers, directors, shareholders, agents, and representatives of the Sponsor, its affiliates, subsidiaries, and advertising, promotion and legal advisors are not responsible for and shall not be liable for: (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, or unintelligible Entries; (ii) any condition caused by events beyond the control of Sponsor that may cause this Sweepstakes to be disrupted or discontinued; (iii) any injuries, losses, or damages of any kind caused by the Prize or resulting from acceptance, possession, or use of the Prize, or from participation in this Sweepstakes; or (iv) any printing or typographical errors in any materials associated with this Sweepstakes.
- (e) J&J reserves the right, at its sole discretion, to suspend, modify or terminate this Sweepstakes (or portion thereof) for any or no reason, including if J&J determines that any portion of this Sweepstakes is compromised for any reason, and, if terminated, at the J&J's discretion, J&J may select the potential winner(s) for the drawing(s) at issue from all non-suspect, eligible entries received for the applicable drawing(s) prior to action taken.
- (f) Participants agree that any dispute arising out of the Program or this Sweepstakes shall be resolved individually without class action and exclusively by the state and federal courts in Effingham County, Illinois, under the laws of Illinois, without regard to that state's conflict of laws principles. **PARTICIPANT, BY ENTERING, SPECIFICALLY AND KNOWINGLY WAIVES ANY RIGHT TO A TRIAL BY JURY AND A TRIAL BY JURY IS HEREBY WAIVED BY BOTH SPONSORS AND PARTICIPANT. PARTICIPANT UNDERSTANDS THAT PARTICIPANT IS WAIVING RIGHTS WITH RESPECT TO CLAIMS THAT ARE AT THIS TIME UNKNOWN OR UNSUSPECTED, AND IN ACCORDANCE WITH SUCH WAIVER, PARTICIPANT ACKNOWLEDGES THAT PARTICIPANT HAS READ AND UNDERSTANDS, AND HEREBY EXPRESSLY WAIVES, THE BENEFITS OF SECTION 1542 OF THE CIVIL CODE OF CALIFORNIA, AND ANY SIMILAR LAW OF ANY STATE, COUNTRY OR TERRITORY, WHICH PROVIDES AS FOLLOWS: "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."**
