## **SELF-LIMIT PROGRAM GUIDELINES**

Upon your enrollment in the J&J Gaming Self-Limit Program, the following guidelines will apply when you visit any J&J Gaming property as operated by the company or its affiliates.

**You are permitted to:**

- Patronize gaming and non-gaming amenities at J&J Gaming affiliated locations

**You are prohibited from:**

- Receiving gaming-related direct mail marketing, telemarketing or promotional mail from J&J Gaming

Your self-limit status will remain in effect for a **minimum of ONE YEAR** from the date of enrollment.



## **CUSTOMER SELF-LIMIT PROGRAM ENROLLMENT FORM**

J&J Gaming (the “Company”) maintains a program in compliance with applicable gaming regulations, including without limitation, Nevada Gaming Commission Regulation 5.170, which allows customers to voluntarily limit themselves from receipt of gaming-related direct mail marketing and other gaming-related marketing privileges offered by the Company.

By completing this form, you are requesting to be enrolled in the J&J Gaming Self-Limit Program. Once your completed form is received by the Company, it may take up to 14 business days to officially process your request. Your self-limit status will remain in effect for a minimum of **ONE YEAR** from the date of enrollment.

1. I, the undersigned Customer, hereby request to be enrolled in the J&J Gaming Self-Limit Program (the “Self-Limit Program”). I acknowledge that my enrollment in the Self-Limit Program will result in the restriction of my receipt of gaming-related direct mail marketing, telemarketing, and other promotional mailing and materials from the Company.
2. I understand my enrollment in the Self-Limit Program will remain in effect for a minimum of **ONE YEAR** from the date of enrollment.
3. I understand and agree that:
  - my self-limited status will remain active for a minimum of **ONE YEAR** unless and until I request to withdraw from the Self-Limit Program and the Company approves my request, in writing, in its sole and absolute discretion;
  - my request to withdraw from the Self-Limit Program must be submitted by emailing a **notarized** Self-Limit Statement of Release to *self-limit@jggaming.com*, or by mailing a completed and **notarized** Self-Limit Statement of Release to J&J Gaming, Attn: Marketing Department, 1500 S. Raney Street, Effingham, IL 62401;
  - my participation in certain state-sponsored voluntary exclusion programs shall supersede my request for removal from the Self-Limit Program and the Company reserves the right to deny my request for removal, in its sole and absolute discretion.
4. I have been advised and agree that if I receive any gaming-related direct mail marketing, telemarketing, or promotional materials **after** my enrollment in the Self-Limit Program, I will contact J&J Gaming at *self-limit@jggaming.com* within ten (10) days of receipt of such information or materials. If I have questions concerning the Self-Limit Program, I will contact the Company at *self-limit@jggaming.com*.



5. For my self-limit status to be truly effective, I acknowledge that I must exercise self-restraint and I should not ask any J&J Gaming employee to provide me with any of the services or privileges which are the subject of this request. I have been advised and agree this self-limit request does not release me from any debts incurred prior to, or after, the effective date of my self-limit status. I hereby release and hold J&J Gaming, its subsidiaries and affiliates, harmless from any claim by me or any third party arising from my presence in or acts upon the premises of any J&J Gaming properties which occur after I become self-limited. I further agree that this self-limit request does not obligate J&J Gaming properties to return and funds wagered by me prior to, or after, the effective date of my enrollment in the Self-Limit Program.
